## Selling plants? Protect your business

**Don't buy, sell or move plants, flowers or foliage that put NSW at risk**

Plants that can harm the environment, economy and communities of NSW are called 'priority weeds'. The sale and movement of priority weeds is restricted under the *NSW Biosecurity Act 2015*. Restrictions apply to all parts of the plant, and to cultivars and hybrids.

**State** priority weeds **must not** be imported into NSW or sold anywhere in NSW.

If you buy or sell **state priority weeds** in NSW you are committing an offence under the *Biosecurity Act 2015*. The plants will be seized and destroyed and you could be fined.

**Regional** priority weeds **should not** be bought, sold or moved in certain regions of NSW.

You have a general biosecurity duty to **prevent, eliminate or minimise the biosecurity risks from regional priority weeds**, as far as is reasonably practicable. If you buy, sell or move **regional priority weeds** without preventing, eliminating or minimising the risks you may be committing an offence under the *Biosecurity Act 2015*. You could be fined and the plants could be seized and destroyed.

## Don't risk it. Check NSW WeedWise

To find out whether restrictions apply to the plants you buy or sell, go to NSW WeedWise at [weeds.dpi.nsw.gov.au](https://weeds.dpi.nsw.gov.au)

To see a list of **state priority weeds that must not be sold** anywhere in NSW:

1. Click **advanced search**
2. Choose **Weed category > Must not be sold in NSW**
3. Click **Search**

To see a list of **regional priority weeds that should not be sold** in your region:

1. Click **advanced search**
2. Choose **Weed category > Should not be sold in parts of NSW**
3. Choose **Region >** select your Local Land Services region

4. Click **Search**

If you are found buying or selling **regional** priority weeds, you will be given the chance to cease the activity, or given the option to show:

- how you've minimised the risk created by the plant
- that you've communicated to your customers that the plant creates a risk to the environment, economy and community
- that the plant is not capable of regenerating or reproducing (by providing a sample for testing)

If you can't show these things, you may be given a **biosecurity direction** that tells you what you must do to minimise the risks created by the plant. If you don't comply with the biosecurity direction an authorised officer could seize the plants and give you an on-the-spot **penalty infringement notice** of \$1000. Further legal proceedings could occur.
