

PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT

FOR QUARANTINE TREATMENT OF ORNAMENTAL SPECIES AND NON-BEARING POTTED FRUIT TREES

PERMIT NUMBER - PER9796

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

BRIGADE GRANULAR INSECTICIDE

PLUS OTHER REGISTERED PRODUCTS containing: 2 g/kg BIFENTHRIN as their only active constituent.

Directions for Use:

Crop	Pest	Rate
Quarantine treatment for ornamental species and non-bearing fruit trees	Identified quarantine soil pests susceptible to Bifenthrin.	Apply up to 6.1 g product per Litre of potting mix in accordance with the critical comments.

Critical Use Comments:

- Any run off from watering of treated pot plants should be prevented from entering drains and waterways.
- Granules to be applied topically to pot surface. Rate is dependent on potting media density.
 The following table is a guide to average densities of commonly used media. Apply
 granules in accordance with the following table. If the media to be treated varies from the
 specified ratios below determine the average composition of the media to be treated and

Potting mix	Specific Gravity	Product g/L
100% peat (light)	0.5	1.6
25% sand/ 75% peat	0.85	2.7
50%/50% sand and peat	1.2	3.8
75% sand/ 25% peat	1.55	5.0
100% sand (heavy)	1.9	6.1

apply the rate of product that correlates with a mix in the table that has a similar density.

Withholding Period:

Not required when used as directed.

Jurisdiction:

ACT, NSW, QLD, SA, TAS, NT, WA only

Note: Victoria is not included in this permit, as their *Control-of-Use* legislation does not require a permit to legalise this off-label use in this state.

Additional Conditions:

DO NOT APPLY TO ANY NURSERY STOCK BEARING FRUIT.

DO NOT APPLY TO VEGETABLE SEEDLINGS OR EDIBLE CROPS OTHER THAN TREES OR VINES.

Safety Directions

Users must wear chemical resistant gloves when applying the product and rehandling treated pots.

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the DETAILS and CONDITIONS of this permit.
